Dear friends!

The year 2018 brought us a lot of positive emotions, but the main successes of the KRBA team should be considered in the context of the biennial cycle. So, in April 2016 our team - a football team of advocates from the Kyiv region - came into existence. In two years, we achieved numerous milestones, both in the national arena and internationally, and came to be the most renowned and high-profile lawyer's sports project in Ukraine. The most prominent successes of ours, are the titles of European Vice-Champion at EUROLAWYERS 2017 (Maribor, Slovenia) and the title of World Champion among lawyers in Mundiavocat 2018 (Cambrils, Spain).

Naturally, every similar project aims to promote the lawyer's profession, to bolster its image and promote the role of the profession in society, to make the profession socially responsible, ensure that its representatives are worthy of the highest recognition in their country. However, this is impossible without close interpersonal ties between the lawyers themselves. Therefore, we consider our greatest achievement over recent years that we made friends - we got to know friends-colleagues, from all over Ukraine, during the National Championship "UNBA Cup 2018", that demonstrated well-developed football regarding both game and organization, as well as abroad - across the world! At the very least, we are quite sure that KRBA team's T-shirts, made their way to all other continents, as we exchanged them with members of participating teams at "MUNDIAVOCAT 2018".

We are pleased to inform you that we plan to unite our friends on October 24-28, 2018 to meet again on the football pitches in Kyiv and at the table with mouthwatering Ukrainian cuisine.

#### Why October?

The end of autumn is the perfect mid-season time between the major soccer forums within advocacy that are held in May-June under the auspices of Corporate Sports Organization. The end of autumn is also aesthetically attractive - the absence of summer heat and winter frost will allow guests to feel as comfortable as possible during the games, as well as in the course of guided tours and rest in the capital of Ukraine.

#### Why Kyiv, Ukraine?

Recent and largely successful UEFA Champion's League final held at NSC Olimpiysky stadium proved that Kyiv is a comfortable location for organizing major sporting events, both in terms of logistics and hospitality, as well as the quality of pitches and vibrant autumn colours, turning it into one of the finest European destinations.

Well, we should also keep in mind that Kiev is home to KRBA Team.



#### The format of the Tournament

Our experience in the largest European and World football forums for lawyers revealed to us that the participants of '5 by 5' category have an unsatisfied need for a classic futsal or mini-football competition. For that matter, we decided to hold our own forum in accordance with the classic rules of FIFA Futsal on the parquet floors or the modern Terra-Flex cover in a closed space, playing with futsal ball, 2 games per day (depending on the number of participants), for the duration of 15-20 minutes (depending on the number of participants).

The admission to participation is similar to the rules of "MUNDIAVOCAT" and "EUROLAWYERS". A team may consist of up to 15 players, all of those must be lawyers, and the possibility for exception covering two non-lawyer participants, that should necessarily be related to the profession (lawyer's assistants and/or trainees). We believe it is fair not to grant admission to the player(s) that played for a professional football team(s) in the course of previous three years.



#### We propose the following schedule for your stay in Kyiv:

**24 October** – arrival, hotel check-in, guided tour and the Draw ceremony in the evening, featuring prominent Ukrainian football players and gala-dinner;

**25-26 October** – group phase;

**27-28 October** – quarter-finals, semi-finals, 3rd and 4th place games and the final;

**28 October evening** – in the evening - Award ceremony and gala-concert.

#### Participants

We invited old friends:

#### Accommodation and participation package:

Registration fee for the tournament is 750 EUR per team and 300 EUR per player.

#### It includes:

- accommodation at a comfortable hotel in a picturesque district of Kyiv City, including breakfast and dinner, for five nights;
- transfer from point of arrival to hotel and back; from hotel to the pitches;
- access to all events on schedule (gala-dinner, gala-concert);
- guided tour around Kyiv;
- welcome souvenirs for every team;
- trophies to winners and participants.
